# 2. Matters Arising

# Short Life Working Group (Community Engagement)

Carin reported that a Short Life Working Group has been meeting and is producing a report to Community Planning Partnership on 31<sup>st</sup> March 2011.

A key recommendation of the report will be the re-establishment and continuance of the lapsed Community Engagement Group. The new CEG will work under the auspices of the five pillars of Community Engagement that the SLWG have developed as a strategy and action plan.

Meeting of November 2010 was cancelled due to adverse weather.

# 3. Budget Consultation

lan and John were acting under instructions by the small working party and by the elected members of the Moray Council.

# (a)Points of discussion:

As the recent consultation process was specifically targeting community group representatives, the Moray Area Forum members expressed a preference that future consultations should be more open to the wider public to attend.

lan informed those present that the evaluation conducted at the community meetings was once again positively commented on.

Kieran felt there was a role for group representative consultations. However, Carin stated that she felt that they were not conducive to being welcoming, open and inclusive to the wider community.

Aileen felt the political perceptive was missing. She didn't feel that officers should be put in the front line when in-fact; it was elected members that were making the decisions.

John (Forres) did not agree with format. Carin felt the format was fine but left little room for wider and more in depth input by participants.

There was consensus that any future consultations must be implemented earlier in the year. Anita requested that elected members give communities more time to respond.

Alan proposed that Area Forum representatives and others meet with Council officials well in advance of any future budget consultations. Elected members should also be involved in these meetings.

lan pointed out that due to some community leaders, including some Area Forum Chairs and members of the public, encouraging through local media outlets that all sectors of the community should turn up on the evenings created concern over health and safety aspects. Ian stated that some staff involved in the facilitation of the meetings had been alarmed and were genuinely concerned by the tone being expressed in the press.

# (b)Communication

Buckie and Forres Area Forum along with a few Community Council representatives met with Alastair Keddie over concerns regarding a Council press release shortly before the Buckie meeting. Local residents were concerned about basic information regarding the process.

Wrong figures were produced by the Council and this was viewed as a serious communication issue, particularly given the short notice of the consultation meetings.

Concern was also expressed that there may have been other 'mistakes' hidden in the budget statement that were circulated by the Council.

# (d)System of Collation

Buckie representation input had gone missing but was found and rectified

#### (e)Facilitation

A few facilitators were felt to be leading. Ian explained that the capacity of CSU staff was stretched and that some facilitators had more experience than others.

# (f)Invites to Community Groups

Ian explained that staff were asked to use a specific database by the organising working party. The only exception would have been Moray wide / National organisations. In addition, Ian instructed local CSU staff to contact local Area Forum and CC chairs / representatives to peruse the lists locally in-case there were groups missed off the list. The majority of local representatives participated in this exercise although, a few did not.

Ian agreed to distribute the list to the Area Forum members before the next meeting.

#### 4. Impact of CSU cuts

Full time MALP Co-ordinator post has been deleted.

Community Engagement Team – 50% reduction in service which equates to two CSOs and two CSW full time posts.

Operational options being explored with staff. Support to community groups and organisations will be severely affected.
