# 1. APOLOGIES

# 2. DRAFT MINUTE OF MEETING HELD ON 9 DECEMBER 2014

The minute was approved as an accurate record of the meeting. Proposed by Laurence Findlay, seconded by Tracey Gervaise.

# 3. MATTERS ARISING

Cllr Skene asked SM if there had been any update regarding "Waves" – there has been no information from Waves yet but there should be shortly.

Corporate Parenting - dates not set yet for the first meeting, JW informed that they should be forthcoming soon.

#### 4. WORKING GROUPS

#### • Getting it Right for Every Child

GIRFEC meeting has produced framework for children's wellbeing. This is useful for everybody, all partnerships included.

Partnership Hub has set out what their vision is together. No one agency can do this on their own and should always act together as a partnership.

Young People in Schools – leaflet for parents has been completed.

Mentioned that NHS are waiting for other leaflets to be produced with information to give to parents.

#### Child Protection

Child Protection Committee – case conference attendance has dropped across the board. LF and SM are investigating why there are not so many attending these.

National Action Plan was discussed, SM attended the meeting last week and has sent information to S Lamberton to collate.

Cllr Skene asked if we have paper in place for child sexual exploitation, SM informed we do have frameworks in place.

WF discussed Looked After Children who go missing, the paper for this is in the process of being re-done. Research indicates that 20 - 30% of Looked After Children have been exploited.

#### • Early Years Collaborative

TG attended the 3<sup>rd</sup> annual event, which was oversubscribed and in attendance were high level speakers. Wave Trust was also in attendance. This event would be good to continue on an annual basis and was very positively received. If the numbers and event grows bigger, then funding will have to be looked at.

Workstream Groups still going forward, PDSA workshop was planned but now the group is looking at being more mobile and visiting staffs work base.

Learning Set 7 - meeting tomorrow in Glasgow

Early Years Strategy for Moray will be brought to the table for partnership.

### 5. FAMILY NURSE PARTNERSHIP

LC, CR and CJ from NHS showed a presentation on Family Nurse Partnership and also handed out leaflets.

The Family Nurse Partnership is being rolled out throughout the whole of Grampian.

This programme is an evidence based programme with over 30 years practice in America. The FNP has been running in England since 2009, and was first tried out in Scotland in 2010.

This FNP is purely for first time teenage parents – the oldest you can be is 19, 20 by the time you deliver your baby. A short DVD was shown. The programme is given by specially trained nurses and helps:-Improve pregnancy outcomes Improve child development

School development Parents' employment

2 nurses will be employed, one in Buckie and one in Aberdeen, 25 clients per nurse.

Cllr Skene asked how the young people enrol for this, CJ informed they have to be first time mothers and must enrol when they are no more than 28 weeks pregnant. The young person can either self refer themselves to this or through the health visitors/midwives.

Health visitors are being replaced with the FNP for 2 years, at 21 months the Health Visitor will be contacted and a joint visit from FNP and the Health Visitor will take place with the young parent. FNP will then visit monthly until the young person is phased back into mainstream healthcare.

TG asked if tools used could be adopted by Health Visitors, this is a licensed programme so the tools cannot be given out and can only be used by FNP.

SM mentioned a potential child protection concern, but if the young person wanted to be part of the programme this has to be voluntary. This is one of the 2 top programmes that help with child protection and is always voluntary.
