Agenda Item 3

Shared Apprenticeship Scheme

The Shared Apprenticeship scheme is piloting to areas in Scotland one of which is Moray. This scheme which has previously been piloted in Wales works on the basis that a number of employers within the same occupational sector share apprentices. The moray pilot will focus on Food and beverage service. There are different models:

- 1 One employer takes the lead
- 2 A training provider acts as the employer (preferred option)

3 Set up a Shared Apprenticeship Limited Company to run the pilot.

Recommended that there is a pre - employment course for a few weeks prior to young people starting the MA framework.

The shared Apprenticeship Scheme sits outwith the NTP current programme and numbers are not counted towards the SG target of 25,000 apprentices in Scotland.

It was agreed that the programme sits within the STG key aims and that there is a need to increase the number of Hospitality MA's in Moray.

Welfare Reforms

Wendy noted that the DWP are likely to receive additional funding to deal with the impact of Welfare Reforms. Developments include pre named post work programme activity which involves: 33% on Daily signing/interventions, 33% on Community Work Placement and 33% on other activity.
