- 4) Relevance of projects currently on MES and ECFTF Action Plans.
- Need to look at what is not currently on Action Plan that could be initiated by group.
- Town Hall refurbishment needs to incorporate facilities and flexibility. Perhaps name change to a 'Moray' facility and an Arts Centre Focus. Need to establish whether this can be done or if they will have to remain two separate projects. Possible funders – Creative Scotland, HIE and European funding.
- Grant Lodge project in progress.
- Story of Speyside in progress, being overseen by Keith Community Council. Dialect an important aspect which could be capitalised on.
- Assisting in hotel development currently in progress at Coleburn Distillery. Need to identify potential new sites, future site being Barmuckity.
- Discussion of Lossiemouth, Seatown Bridge. Currently on Moray Council Capital Planning Reserve List.
- Possible conflict between Grant lodge and plans for St Giles Church becoming a Visitors' Information Centre.
