#### – OT

While we're talking about health and social care and the services that will be part of the new IJB set-up, have any of you needed the Occupational Therapy (OT) service? We spend £313,341 a year providing equipment and minor adaptations to help people through a post-op recovery or conditions, from a pair of crutches (£15), a raised loo seat (£45), through to purpose-made aids costing many hundreds. Equipment can be re-used but is infrequently returned once they're no longer ne...

# 13/09/16 – School Crossing

We spend £259,000 every year on providing school crossing patrollers. We, along with lots of other local authorities, have provided this service on a discretionary basis because of national guidance which makes it clear this is seen as best practice. However, there is no legal obligation on us to provide school crossing patrollers, and it is the duty of parents to ensure that your children arrive safely to school. Can you ensure your child arrives safely without our help?

## 15/09/16 – Community Wardens

We've had some brilliant feedback on the school crossing patrollers, thank you everyone. That thread isn't closed, but over the next couple of days we'd like some views on our Community Warden service. They work to reduce crime, reduce vandalism and anti-social behaviour, improve the environmental quality of life, and assist in building community pride. For most of this year however, 28% of their time was spent dealing with dog fouling.

In other areas across Scotland, Community Wardens are responsible for issuing parking tickets; in some places they wear small cameras or have access to CCTV vehicles. What do you think of the Community Warden service? Should we keep it?

# 19/09/16 - CCTV

CCTV has been in use in public areas for several decades. It is used to deter crime and antisocial behaviour, to investigate offences and as evidence to prosecute crime. In Moray, we spend £52,000 per year on CCTV which is operated by the police as part of the overall strategy to reduce crime and aid with the detection of crime. However, nowadays many private businesses have their own CCTV systems to cover their premises, police officers wear Go-Pro style cameras on their tunics and camera phones are everywhere. Do we still need static CCTV?

## 19/09/16 – Corporate Services

We've had a few posts in this series of budget conversations telling us to cut the number of managers in the council – and we are undertaking a review to ensure the structure we have is fit for purpose. But the people that work in what we call the corporate services area of the council – HQ in other words – are part of a support service that every large organisation must have to function. Services such as HR, IT, accountancy, procurement, legal, are all necessary to ensure the council delivers at the front line. Moray Council has one of the leanest management structures in Scotland's public sector; 4.2% of our total gross budget against a Scottish average of 5.1%, and we've even reduced that from last year's 4.6%

figure. In hard cash terms that's £26,649 per 1,000 population. But, we have to save money so we're open to any suggestions you might have to help us do even better.

# 20/09/16 - Digital Services

We've seen lots of feedback from you about doing more online, both us as a council and for you as a customer. Results from a survey released by our Moray Connected team show that almost 40% of you use our website out of hours, and 70% of you want to use online services. Because of this, we're adding ways to report and request things online, which can be done quickly, on the move and has 24/7 availability. We're also looking to purchase a booking and payment system within the ...

# 21/09/16 – Legal Services

At £62 an hour, our legal services costs are roughly half those of the private sector. #### 26/09/16 – Education Introduction

We're moving the conversation on to education this week. This is a big ticket item that consumes £94 million a year – nearly half the council's budget. As a starter, we'd be interested in a conversation with you about schools in Moray. We're told there's a teacher shortage in Moray and across Scotland, but here's an interesting fact: apart from national shortages in some secondary subjects such as maths and sciences, we have enough teachers for all our pupils.

## 30/09/16 – School Transport

School transport costs just over £4million a year, and in Moray we're pretty efficient at it. Our statutory requirement is to provide transport to school to those pupils 8 and older living 3 miles or more from school. However we have elected to provide transport to those within a 2 mile radius, the same as for under-8s. Delivering the legal minimum for over-8s could save a small amount of our annual bill for starters.

## 03/10/16 – Winter Transport

We all want our roads cleared to get us to work in the winter mornings. We prioritise the roads gritting to help achieve this, but all roads cannot be cleared by 7am due to our large roads network. How can we manage your expectations of all roads being clear by the time you travel to work? Would gritting the roads just at night but not in the morning work? Reducing the number of priority routes we grit or could we all change our driving habits to mitigate a reduction in the service? Sometimes knowing that the roads are not treated means we plan for adverse conditions a bit better by fitting snow tyres, etc. We could potentially save up to £600k by significantly reducing the service, but what do you think? #getinvolved

# 05/10/16 - Recycling

Thank you to everyone who joined in the chat about road maintenance, some very positive comments and workable ideas there that will be forwarded to councillors to inform their budget proposals. You can add more at anytime, but today we'd like to talk about recycling. We - or more accurately, you - do pretty well in the recycling stakes. Moray is repeatedly in the top three councils for this, currently recycling 57% of all waste, saving you £2.45 million a year.

The Scottish Government has set a target of 70%, to be the best in Europe. To achieve this requires a big effort, but it would save a whopping £3million in landfill tax. What can we - and you - do to keep plastics, paper and tins out of the green bin and save that cash?

#### 07/10/16 – Grounds Maintenance

Following on from our recycling chat, we should think about our grounds maintenance operations. We cut this quite a bit last time around and some groups have stepped up to fill the gaps with great success. Dufftown, Duffus and Forres spring to mind, where the community have achieved amazing results and awards (see pic of Forres display) Our ground maintenance teams also dig graves, spray weeds, maintain playpark equipment, manage parks and woodland areas and a host of other jobs to keep Moray looking good. It all costs nearly £1.3m a year.

In how many of Moray's towns and villages is there the potential for more community involvement in this maintenance, including perhaps some cemeteries? What support would this need to be sustainable? We'd like to hear what you think.

## 10/10/16 - Libraries and Leisure

This week we'll be talking about libraries and leisure facilities. If you've read our booklet on the council's budget (http://www.moray.gov.uk/downloads/file106771.pdf) it's clear that closing all libraries and leisure facilities will not close our funding gap by enough to solve the problem.
