Computer Based Crime - Sextortion

What is sextortion?

When someone you have met online encourages you to carry out a sexual act in front of your Webcam and then threatens to post a recording of you online or send a copy to friends

or family unless you pay them money. This is a form of blackmail known as sextortion.

Why me?

The vast majority of these incidents are perpetrated by professional criminals looking to make easy money. Hundreds of similar cases are reported to UK Law Enforcement each year and thousands more are recorded world wide.

What should I do?

Don't Panic

The first big step is to recognise you are the 'victim' in this and that you may require support to help you through what has happened.

Don't pay

The choice to pay is yours but experience shows where victims have paid then there is no guarantee that offenders will not still post the recording and are in fact more likely to come back with further demands.

Moray Central Community Council Report



This report covers progress we have made in dealing with your priorities for the Elgin Community Policing Team area during the period of April 2021.

The report aims to highlight emerging issues in your area, and to provide crime prevention advice and guidance to Community Council members and residents you represent. Our focus is to reduce crime and disorder, help create safer communities and respond effectively to local concerns.

Local Policing Priorities

Antisocial behaviour, Violence and Disorder:

Vandalism

April saw a similar number of Vandalisms as the preceding month.

Amongst the incidents reported was damage to property at New Elgin Primary School. Suspects have been identified and enquiries are ongoing.

A business premises in Thunderton Place also had a window damaged. Enquiries are still ongoing to trace the person responsible.

Assault

April has seen an increase in the number of Assaults with 14 being reported to Police. Two youths have been charged with assaulting another youth in Warden Place and have been reported to the Youth Justice Management team.

A 13-year-old youth was assaulted by another youth and sustained a black eye. A report has been submitted to the Youth Justice Management team.

A 38-year-old male was the victim of an assault carried out by a 41-year-old male whilst within his home address, sustaining a small cut to his face which required stitches. A report has been submitted to the Procurator Fiscal.

Police were called to a business premises on Elgin High Street, following reports of a male behaving in a threatening manner within. A 54-year-old male was arrested and charged with contravening the Criminal Justice and Licencing (Scotland) Act 2010, and a report has been submitted to the Procurator Fiscal.

Police were called to a property on the outskirts of Elgin after reports of a male behaving in a threatening and abusive manner while under the influence. A 59 year

old male was soon after arrested and charged after Assaulting 2 Police Officers. The male has been reported to the Procurator Fiscal.

A 36-year-old male has been reported to the Procurator Fiscal after behaving in a threatening manner towards his neighbour in the Pinefield area.

Drugs

Over the course of the month 6 persons were found in possession of personal amounts of Cannabis.

A 28-year-old female who had been arrested for committing theft and breaching bail conditions was found in possession of cannabis.

A 25-year-old male was stopped by Elgin roads policing team. As well as being cautioned and charged with driving offences they were charged with being in possession of cannabis.

Acquisitive Crime:

Theft

April has seen 9 reports of theft a reduction from the previous month.

A 28-year-old female committed around a third of the month's offences and was arrested for stealing, amongst other things, a wheelie bin. A report was submitted to the Procurator Fiscal and the female appeared in court from custody.

A building site in the Bishopmill area has seen another Theft by Housebreaking. Suspects, who are unknown at this time, entered into the building site and left with various tools and other equipment. Efforts enquiries are still ongoing to identify those responsible.

A business premises in Wardend Place was broken into with over £6000 of damage caused. Three youths were identified as responsible and have been cautioned and charged with various offences.

Road Safety & Road Crime:

Across Elgin the Roads department and the community Policing team have been out continuing to tackle the issues surrounding Road traffic issues and antisocial behaviour.

A 29-year-old male was stopped on Thornhill Road and found to be driving without a licence, valid insurance or a MOT. A report has been submitted to the Procurator Fiscal.

A 32-year-old male was stopped on Elgin High Street and found to have no insurance. As well as this he was also charged with the vehicle having a dangerous load.

A 29-year-old male was caught driving at 97 mph on the A96 between Elgin and Lhanbryde.

A 44-year-old female has been reported to the Procurator Fiscal having been caught drink driving in the New Elgin area. As well as this she was also found to have taken the vehicle she was driving without the permission of the owner and had driven with no insurance.

A 25-year-old male was stopped by officers due to the manner of his driving and subsequently was cautioned and arrested for drug driving having tested positive for Cannabis. A report has been submitted to the Procurator Fiscal

Community Engagement & Reassurance:

Community Officer Jamie Dey carried out various duties over the course of the month including attending at the Cooper Park to take part in the Elgin Youth Development group Friday fun day that takes place every Friday afternoon for s1-s6 students. He engaged with over 15 Youths as well as Youth Workers with future events being discussed.



Constable Dey also attended at a number of Elgin Primary Schools in relation to a number of complaints by local residents regarding parking issues. Seafield and New Elgin Primary in particular with the Road safety Scheme now in full operation

Constable Dey is continuing, in partnership with Moray Council, the setting up of a summer programme which will be finalised in May.

Moray West Community Council Report



This report covers progress we have made in dealing with your priorities for the Lossiemouth & Fochabers and Forres Community Policing Team areas during the period of April 2021.

The report aims to highlight emerging issues in your area, and to provide crime prevention advice and guidance to Community Council members and residents you represent. Our focus is to reduce crime and disorder, help create safer communities and respond effectively to local concerns.

Local Policing Priorities

Antisocial Behaviour, Violence and Disorder:

Lossiemouth & Fochabers Area

There have been three reports of petty Assault during the month and enquiries are ongoing into these incidents with one perpetrator identified and reported accordingly.

A report of vandalism to the new Lossiemouth High School building was reported and an individual has been traced and charged.

Enquiries are ongoing into two reports of vandalism to cars in Burghead.

Forres Area

During the early part of the month, an Attempted Murder was reported at an address in Forres. This was a contained incident and the persons responsible were quickly identified and taken into custody with no risk to the wider public.

Similarly, during the early part of the month, a fire destroyed two buildings of prominence at the Findhorn Foundation. A male was quickly identified and taken into custody. Again, this was a contained incident with no threat to the wider public.

Four petty assaults were reported with some variously detected and enquiries are ongoing into the others.

Over the course of the month, seven vandalisms were reported, and enquiries are ongoing into these incidents with a number of positive lines of enquiry identified.

Two males were reported individually for the possession of a small amount of drugs.

Speyside Area

I am pleased to report that there has been no incidents of Assault during the month other than the apprehension of a female, known to Police Officers, who became violent during Police led enquiries into an incident at her address.

Acquisitive Crime:

Lossiemouth & Fochabers Area

Enquiries are ongoing into a report of a break into a shed in Lossiemouth

Forres Area

One Housebreaking was reported along with a separate attempt to gain entry to a motor car and steal items from within it. Enquiries are ongoing into both incidents.

Speyside Area

During the month, Officers were alerted to a report of salmon poaching on the river Spey. In conjunction with Roads Policing Officers, a number of central belt-based males were traced and arrested and reported for poaching offences.

Road Safety & road crime:

Lossiemouth & Fochabers Area

A number of motorists were reported for speeding offences as a result of attention paid by Roads Policing Officers to traffic passing through the College of Roseisle.

Other offences reported during the course of the month included careless driving, and overloaded vehicle and persons driving with no insurance and no MoT.

Forres Area

A small number of drivers were reported for speeding offences in and around the Forres area. No other driving offences were reported which is pleasing to note.

Spevside Area

There was one report of dangerous driving in Rothes which was detected.

A number of motorists were reported for speeding offences across the area and also other offences relative to driving with no insurance and no MoT.

Community Engagement & Reassurance

Over the course of the month, reports of youth annoyance continue to be received at different locations in Forres. Officers have responded to these incidents and interacted with several youths during which time alcohol was seized. Consequently, identified Community Officers and Special Constables have carried out dedicated plain clothes patrols at known hotspots to augment the high visibility patrols already taking place. These patrols will take place for a number of weekends. Liaison has also

taken place with British Transport Police to identify youths who are travelling on the rail network into Forres from elsewhere. Overall, on the first weekend, this had the desired effect of disrupting the youths. Social media messaging has also been employed to highlight the issues to parents and to request their help in knowing where their children are and encouraging them to behave appropriately.

A positive meeting was held with various partners to find a way of addressing issues of vandalism at Drumduan School and an identified Officer will lead on this issue going forward.

In Lossiemouth, Officers have been in contact with the Head Teacher at the new High School to address issues relative to youths congregating at the rear of the building after school hours. It is hoped that with regular patrols of the area and working in close liaison with School staff, this problem will be managed positively.

Working together for a safer Scotland



Over the past year the Scottish fire and rescue service has seen some significant changes to the way in which we deliver our safety messages to our local communities. Prevention activities is one of our key objectives making sure we are safe in our homes not matter where we reside. The Covid-19 pandemic has temporarily changed the way we operate, but hopefully soon we may be able to get back out into our communities to deliver face to face safety advice.



Our Community Action Team are phoning occupiers and providing key advice on how to stay safe at home (new referrals, revisits, self-referrals, website queries) offering fire safety advice

Due to Covid-19 restrictions SFRS are not carrying out Home Fire Safety Visits at the moment, we are only attending properties with <u>No working smoke</u> <u>detectors</u> and installing detection, to ensure everyone is safe in their homes, also HFSVs are only being carried out if there is evidence or risk of fire related crime. In the Moray Area our Community Action Team along with operational crews are working closely with our partners taking a proactive approach to identify the most vulnerable members of our communities, and to ensure they receive the necessary support, advice and fire protection needed to make sure they are safe in their homes.

Make the call

Local firefighters are calling on communities to help stop preventable deaths in house fires – by making a five-minute phone call.

"Make the Call" is a hard-hitting appeal to carers, family, friends and of those who are at risk of serious injury or even death because of an accidental fire in their home.

If you, or someone you know is over 50 years old and smokes and either lives alone, has mobility issues or uses medical oxygen, we need your help to identify them. Ask them to get in touch or if you are a family member or a carer, refer them to us. We will undertake a Home Fire Safety Visit where possible. <u>Make the Call</u>, it could save a life.

Key advice on how to stay safe at home is also available over the phone, by email, or via our website.

Increased fire related activity during the spring period:

SFRS see an increase in the amount of outdoor fires over the Spring season. These take firefighters away from other incidents and could put a risk to life, property and can have a detrimental financial impact on the economy.

Local crews are working together with partner agencies to reduce preventable fires and keep people safe – but we need the public's help to achieve these goals.

Local crews are working in conjunction with rural communities, businesses and landowners will support the use of 'Fire Plans' to prevent major fire emergencies involving heath, moorland and forestry.

Many wildfires are started deliberately or are due to careless, reckless or irresponsible behaviour. If you suspect someone of acting suspiciously, recklessly or irresponsibly in the countryside call Scotland Crimestoppers anonymously on 0800 555 111 or call Police Scotland on 101.

Information and advice is readily available about preventing countryside fires, such as the Muirburn Code, which applies to the controlled burning of heather within the permitted season period. Following a significant grass fire at Kingston beach back in March, local crews from Elgin, Lossiemouth and Fochabers have taken a proactive approach in the local area engaging with landowners, the forestry commission and local community groups.

The aim of this initiative is to highlight the increased risk of wildfires at this time of year, and the preventive steps landowner can take to reduce the risk of any significant wildfires.

Keys safety messages are being sent via online platforms promoting fire safety in the countryside and actions members of the public can take when out visiting our beautiful area.
