Chair Persons Update	<p>Area Forums are a platform for local people and organisations to come together and an opportunity to comment on planning and delivery of services and finds out about local concerns and listens to issues. It has been a quiet year with no funding to distribute. FAF is funded by the Community Engagement Group and we have been raising our own funds to boost finances i.e. coffee mornings. Major spend of funding was on sending Moray representatives to Expo which is a good way to publicise the whole of Moray and Forres. We have continued to network with other Moray wide groups such as the Moray Forum. We were partners in the Moray Towns Partnership which has funded us in previous years, it has met less frequently over the past year.</p> <p>Transport Seminar is attended by Angela, currently in abeyance at present as unable to track down minutes of the last meeting.</p> <p>FAF works with FACT and is in a strong position as the town hall has been taken over by the community this allows entry to the Moray Federation of Community Halls and Associations. FAF also participates in Money for Moray and we hear from local initiatives such as the A96 Group and Findhorn Bay Arts.</p> <p>Thanks go to Tina and John and those who attend for sustainable support over the years.
