Health

- Health and wellbeing element to be added to HMP Porterfield focus group programme
- 'Making every opportunity count' approach actively promoted to various agencies (Criminal Justice, SACRO, Turning Point Scotland, TSI, Victim Support, Police Scotland).
- Young people: looking to link in to youth services, specifically Police Scotland Youth Volunteers, Early Intervention Officer and School Liaison Officer.

Training

- Thanks to Caroline Cooper and Families Outside for offering half-day training 'Out of the Shadows', covering families' need for support, promoting family engagement, impact on children and examples of good practice. It takes place at Elgin City FC on 29 November, there are 40 places and it's oversubscribed. Caroline will look at viability of offering a second event in the New Year.
- Any other offers of training that would be of benefit to partners are very welcome.

National events

- MW attended the National Violence Against Women Network Conference on 1 November. The theme was 'Tackling violence against women and girls is everyone's' business'. Awaiting slides from the day, please email MW if you'd like to see these. LS submitted a 'Situation/ Background/ Assessment/ Recommendation' paper to the Community Safety Strategic Group that immediately preceded this meeting on options for reviving the Violence Against Women group in Moray. To be taken to Chief Officers Group by Maggie Miller and Jim Grant.
- MW attending national CJ Coordinators' event at COSLA on 20 November. Wide-ranging agenda, including approaches to Youth Justice. Details to be circulated after the event and slides will be made available if anybody is interested.

5. Partner updates

Police Scotland

Colin Taylor reported on local progress on the Police Scotland Youth Volunteers scheme:

- Originally targeted on east Moray (Buckie and Keith) but take-up had been disappointing so now looking to create a Moray-wide group based in Elgin
- Scheme is aimed at 13-18 year-olds with group comprising up to 24 young people, 25% of whom will have come from deprived/ excluded backgrounds
- Members undertake training before getting involved in a range of volunteering tasks
- The Moray group aims to be active from January2018 and is being led by PC Yvonne Squair.

Moray Alcohol and Drug Partnership

- PJ explained that work would begin shortly on the 2018-21 MADP plan.
- Early indications of future national funding from Scottish Government received but allocation model not yet clear.
 Funding is likely to be linked to partnership work.
- PJ will forward details to MW when situation becomes clearer.
