4. Youth Justice statistics	Item deferred as figures will not be available until July 2018.	
5. Caledonian system	TR described the Caledonian system and gave a resume of the funding event she had attended in Inverness on 26 April, also attended by WS of SPS. The closing date for funding applications is 15 June with the announcement of awards on 16 July. A briefing note is being circulated to all MCJP members with this minute.	
6. Events sub- group update	Group comprising EJ, TR, PJ, JMc, MW has met three times and made good progress. A Community Justice event will be held at Elgin Town Hall on 13 September subject to Community Asset Transfer of the building. Contingency arrangements required in case Town Hall ceases to be available.	
	Karyn McCluskey (Chief Executive, Community Justice Scotland) has accepted invitation to speak.

7. Partner updates	Moray Alcohol and Drug Partnership	
	Scottish Government is reviewing drug and alcohol strategies and developing a 'Treatment Pathway'.	
	MADP is reviewing its three-year delivery plan and is seeking comments, keen to ensure that plan is compatible/ aligned to partners' plans. The focus of the plan is early engagement and reducing harms caused by drug and alcohol use.	
	Final clarification still awaited on 2018-19 funding from Scottish Government.

	Universal Credit goes live in Moray from 27 June. Staff training is currently underway. Partner training events are being delivered by Jane Munro. Anybody who has been unable to book a place should contact Mandy.	

There is significant client anxiety about migrating from existing

benefits to Universal Credit but DWP staff have been able to allay many clients' fears. Final migration of clients to Universal Credit will not be completed until 2020.

Youth Justice

Alan had attended National Youth Justice Conference and a Whole System Approach event. There was currently much discussion on how Youth Justice is now located in different areas of local authorities (e.g. Criminal Justice or Children & Families) and this is being looked at.

Scottish Prison Service

Smoke free prisons policy takes effect in November 2018. Advice and support is being offered to smokers although turnover of prison population makes it difficult to provide a consistent approach across the Prison estate.

Planning to review Housing's Prison Discharge Protocol (with CC).

An update was provided on the new Inverness prison planned for 2020. The site has been cleared in readiness. Project dependent on future Government funding with other capital projects competing for funds.

Housing

Reviewing Housing's Prison Discharge Protocol.

There continue to be problems with some prison discharges although Carol acknowledged HMP Inverness were very supportive.

Families Outside

Undertaking work on the rights of children visiting prison. Two CPD training sessions to be delivered in Inverness and hopefully Moray. Also, teacher training being delivered, raising awareness of issues for children dealing with parental custody.

Also exploring scope for 'virtual' visits as an alternative to families having to travel long distances or not meeting at all.

Police Scotland

Update on Police Scotland Youth Volunteers scheme. Some places are reserved for youngsters from deprived groups and there are still some spaces available. We can expect to see YV's at public events in Moray in the near future.

Moray Women's Aid

Two-year contract with Moray Housing Services is close to being
